## **Terms and Conditions of Entry**

Please ensure that you read and comply with the rules below:

- Exhibits must be on display by 10am each day. Exhibits will not be permitted entry after this. **No exhibits to move around site after 10am**, with the exception of attending the ring parade.
  - **Vehicle access on and off rally fields not permitted between 10am-4pm** except in case of emergency. Anyone arriving after 10am will be asked to park in car park until 4pm. This applies to all vehicles in the rally fields, including camping.
  - **One caravan per entry**, public camping is available for extra units. Contact your section secretary for this.
  - Caravans must be located 20 feet between drawbars.
  - Secondary vehicles may be asked to park in car park due to limited space.
  - Exhibitors will only be allowed access to the site from Thursday pm unless prior arrangements are made with their appropriate section secretary.
  - All caravans and exhibits must be removed by Monday 1pm.
  - All Flammable fuels must be kept in suitable containers.
  - Chemical toilets only to be emptied into Elsan tips provided.
  - All rubbish must be either taken home or placed into skips provided.
  - Please ensure that all dogs are always kept on a lead, including in the Car Park Field. Please pick up all dog mess and dispose of it in any of the bins on site.
  - Any unsafe practices or hazards should be reported to a committee member immediately.
  - Follow all safety signs displayed on the field.
  - Follow any instructions from committee members, stewards and rally volunteers.
  - Failure to comply with our terms and conditions may result in you being asked to leave site.
- **Arrival on Thursday is subject to £5 camping charge. MUST BE PAID IN ADVANCE. Free camping from Friday. This applies to exhibitors and traders. Please note 1 caravan per stand.**
- **All Trade stands must have public liability insurance.**
